It is further agreed that all food and beverages, including liquor, delivered to or served on the premises must be approved by the Rabbi of the Congregation as to acceptable Kashruth.

No deliveries are permitted to be made after the beginning of the Sabbath or Holiday.

All caterers and food establishments hired by the applicant for the stated function must be under the certification of the Rabbinical Council of Greater Washington.
